9.50 The strategic and political context – surface water management

The purpose of this slot is to cover the current strategic and policy context for surface water management and also explore the post-election scenarios that are emerging.

9.50 The Current policy and Strategic Context Elliot Robertson Head of Inland Flooding

Urban areas are net exporters of water because urban areas are very effective systems of rainwater harvesting. It is managing and dealing with this exported water that is the difficult and expensive problem: over 60% of the total asset value of the water industry is sewers. This presentation will address three points:

- Why is England and Wales 30 years behind Germany in adopting sustainable urban water management?
- What is needed for us to catch up? In particular, where is primary legislation required?
- The post-election political context – what is being proposed?

10.40 **Understanding Changing Weather Patterns**

Paul Davies Chief Hydrometeorologist
Flood Forecasting Centre

Whilst much debate has focussed on climate change and future predictions, over the last decade many 'routine' or 'extreme' weather events have posed serious challenges to FRM managers; this presentation will review the realities of our recent weather patterns in the context of likely longer term changes including:

- Extreme events becoming almost annual in occurrence (York, Carlisle, Hull, Gloucester, Glasgow, Belfast, Sheffield, South Wales)
- These have been dwarfed by the 30cm of rain that fell on Cumbria in November 2009
- Flash flooding caused by 5-10cm of rain falling in short durations also appears to have increased
- Realistically what should we be preparing for?

11.10 **Paradigm change for surface water management** **Chris Digman** MWH

The traditional view of urban drainage had major combined sewers at its core. However, the lack of adaptive capability of these systems when faced with even 'routine' flash flooding is suggesting that a fundamentally new paradigm is required. This talk will cover:

- Future challenges and why we need a paradigm shift in our thinking
- How we can structure our approach to deliver sustainable surface water management measures in the future.
- The tensions between the economic need for regeneration and the space to manage flood water.
- Why we need for greater engagement with planners and urban designers in new development
- Why we also need to get the public on board
- And the wider benefits that can arise for placing water at the heart of urban design.

Although it has been widely recognised that partnership working would be needed to deliver surface water management schemes up until the F&WM Bill none of the existing systems facilitated this; this presentation will develop how partnership working may operate in practice including:

- What's intended by the Bill? Current best practice and persistent barriers?
- Look at the generics of multi-objective, multi-benefit – multiple agency schemes
- Considering the financial dimensions of partnership schemes – better value for money
- The talk will be illustrated by case study examples including the IUD & SWMP pilots

13.20 **Challenges facing lead local flood authorities** **Deborah Fox**, Senior Manager, Environment and Economy, Surrey County Council & Member of LGA Inland FRM Group

The presentation will provide an overview of the challenges facing local authorities as they take on the new role of 'lead local flood authority'. The presentation will explore:

- Do they have the necessary knowledge, skills and powers to deliver this role?
- Are there sufficient resources to meet the challenge, at a time when there is pressure on both capital and revenue budgets.

- What do other bodies need to do, to ensure that residents and businesses receive the best outcomes on flood risk management in local areas.

To illustrate the challenges, Surrey County Council's approach to collaboration and surface water management planning in a two-tier area will be given. The presentation will have a policy perspective rather than a technical one.

In many settings especially the urban environment the Highways Authorities will be key partners in delivering surface water management; this presentation will explore the developing issues including:

- Current developments
- Financial aspects: funding sources and the importance of matched funding
- Community involvement: the importance of hearing the community voice; the evidence base
- Potential conflicts about the functionality of roads in relation to drainage

- Concern and evidence that climate change and urban creep is going to continue
- PR09 Final Determination - investment to be justified by outputs
- High level strategy to combine flooding and surface water reduction to achieve the required regulatory targets
- Stressing the need for seeking out opportunities for collaboration, which equates to integrated solutions
- Sources of flows not being simply run off from covered areas, (some direct watercourse inflows; can't assume everything works like it says in the textbook!)
- Management issues that optimisation will demand
- A Water company view on partnership; 'refinement' of the current regulatory regime to accommodate partnership working issues and budget cycles out of synchrony
- Working with other organisations - maintaining effort in influencing others to remove and not add more flows – the water company can't build its way out of this
- Case studies of current projects illustrating solutions
